## Spreader Settings

To apply 1 lb. of Nitrogen MOST 12-4-8 45% SCU with 2% Iron will cover 6,000 sq. ft.

NOTE: Spreader settings are approximate. Differences may occur due to condition and age of spreader, speed at which applied and terrain of area treated. Calculate the size of the area to be treated and do not over or under apply. Close spreader when filling, stopping or turning. Do not hand spread. Calibrate spreader routinely to assure proper rates.
